OUR SERVICES

HOUSING AND HOMELESS SERVICES

Drop In Center (DIC)

This program is the South Los Angeles homeless access center for emergency intake, placement into shelter, transitional housing, and permanent housing referrals. Limited office hours.

Intensive Case Management Services

The Department of Health Services funded program provides field-based intensive case management and housing navigation support to individuals that are homeless and recently from hospital or recuperative care facilities.

Home and Family Program (HAF)

This program provides families experiencing homelessness with a pathway to permanent housing. HAF assists families with housing location and navigation, permanent placement, short to medium term rental assistance, and support to sustain housing once the assistance has ended. Our goal is to help families obtain permanent housing and sustain housing once the assistance has ended.

*Crocker Location

Coordinated Entry System (CES)

SSG/HOPICS serves as the lead agency for the SPA 6 CES which is a collaborative effort to homelessness in SPA 6. This system is designed to serve the most vulnerable population through centralized resources, data sharing and leveraging existing resources.

Family Crisis Housing Network (SPA 6 FCHN)

This program provides short term crisis housing to families experiencing homelessness in SPA 6. The Network was put together and is managed by SSG/HOPICS. FCHN is comprised of crisis housing providers throughout the region. SSG/HOPICS is co-located at the SPA 6 Family Solution Center and places households into the most appropriate housing facilities. *Offsite



SUBSTANCE USE AND MENTAL HEALTH SERVICES

Community Assessment Service Center (CASC)

SSG/HOPICS is the designated substance use disorder (SUD) Assessment and Services Center for SPA 6. CASC provides SUD assessments, referrals and placement into appropriate treatment; and provides case management and linkages to ancillary services. The CASC serves all adult populations. CASC staff are co-located at County offices including Probation, Children and Family Services and Pubic Social Services.

*Broadway Location

Adult Outpatient Program (AOP)

This program provides a broad range of outpatient mental health services for adults. Services include individual, group and family mental health counseling and support. Additional supportive services are provided including case management, psychiatric evaluations and medication management.

*Broadway Location

Outpatient Substance Use Disorder Treatment

These programs provide outpatient treatment, education, counseling and rehabilitation to individuals with substance use disorders. The Family Drug Dependency Court program (FDDC) serves parents assigned to SUD treatment by a judge. FDDC aims to empower parents to become drug and alcohol abstinent, thus increasing the likelihood of family reunification. The Day Reporting Center (DRC) serves male transitional age youth ages 18 to 25. DRC aims to reduce risky behaviors and stop the cycle of recidivism.

Trauma Recovery Center (TRC)

This program provides improved access to mental health services to underserved crime victims through partnership with local service providers and the District Attorney's Victim Assistance Center.

RE-ENTRY EMPLOYMENT SERVICES AB 109

This program provides employment preparation and training, job placement, and job retention services. Services are provided to ex-offenders under Post Release Community Supervision (PRCS). Individuals must be referred by the Probation Department.
