## CLEARING OUTSTANDING TICKETS AND WARRANTS

This free virtual workshop is open to any veteran in need of help with:

- ▶ Tickets for minor offenses (infractions) such as jaywalking, running a stop sign, etc.
- ▶ Failure to Appear charges & warrants stemming from tickets.
- ▶ **We are unable to assist with parking tickets or out-of-state tickets.**

## CLEANING CRIMINAL RECORDS

This free workshop is open to any veteran in need of help with:

- ▶ Information regarding what convictions can be expunged
- ▶ The criteria to qualify for expungement
- ▶ Forms need to be completed
- ▶ Where to file for expungement
- ▶ **We are unable to assist with Federal convictions, or, convictions outside of the State of California.**

## **CLEARING OUTSTANDING TICKETS AND WARRANTS**

- ▶ **Driver License** (or Driver License number)
- ▶ **Original Citations** (the ticket you received)
- ▶ **Any notices or letters from the courts, the DMV, or “GC Services”**  
“GC Services” is a collection agency. Past due fines are sent to this agency for collection.

**FOR MOVING VIOLATIONS ALSO SUBMIT** (tickets you received while driving)

- ▶ **DMV Record**

  - › Requires user login and \$2 fee. Can purchase for \$5 at DMV office
- ▶ **Superior Court Record**

  - › Print details of all tickets/citations
- ▶ **We are unable to assist with out-of-state tickets** – If you’ve received a ticket outside of California in the last 5 years, please contact the DMV of the state in which you received the ticket.

## **CLEANING CRIMINAL RECORDS**

For best service, please provide a copy of your record from court or your DOJ Rap Sheet, if you have it. To obtain case information, call the criminal department of the courthouse where the conviction occurred and ask the clerk’s office for a complete print-out of all of your criminal convictions.
