GARY TSAI, M.D., is Medical Director and Science Officer for Substance Abuse Prevention and Control, a division of the Los Angeles County Department of Public Health. He is responsible for data analytics and clinical leadership to oversee a full spectrum of substance use disorder prevention, treatment, and recovery support services. He is board certified in general adult psychiatry and addiction medicine, and continues clinical practice at Cedars-Sinai Medical Center.



RANDOLPH HOLMES, M.D., is Medical Director for L.A. CADA. He is Board Certified in Family Medicine and Addiction Medicine, and a staff physician at PIH Hospital, in Whittier, where he also maintains a private practice. Dr. Holmes is Chairperson of the Public Policy Committee for the American Society of Addiction Medicine (ASAM) and the California Society of Addiction Medicine (CSAM). He received his Bachelor's Degree from the University of California and his Medical Degree from the University of Southern California.



DESIREE CRÈVECOEUR-MACPHAIL, Ph.D. is Director of Quality Assurance and Utilization Management for L.A. CADA. Dr. Crevecoeur-McPhail is the author of several papers on the effects of addiction on the brain, withdrawal, methamphetamine use by American Indians and Latinos, and treatment effectiveness. She received her doctorate from Claremont Graduate University in social psychology and a master's degree in clinical psychology from Pepperdine University.



THOMAS FREESE, Ph.D. is Director of Training for UCLA Integrated Substance Abuse Programs. He serves as Principal Investigator of the Conrad N. Hilton Foundation Youth SBIRT Training and Technical Assistance Grant, and Director of the Pacific Southwest Addictions Technology Transfer Center, funded by SAMHSA. Dr. Freese has conducted worldwide trainings on topics that include implementing integrated treatment, SBIRT, medication-assisted treatment, methamphetamine use, addressing the opioid epidemic, and culturally-responsive treatment for LGBTQ clients.



NEVA CHAUPPETTE, Ph.D. is a licensed psychologist with 25+ years of experience supervising staff burdened mul-tiple morbidities and treating patients burdened with those same morbidities: addiction, mental illness and HIV/HCV. Some of her patients are also burdened with the minority stressors often tied to being a member of the LGBT community. She employs a patient orientation that is egalitarian and utilizes Evidence Based Treat-ments (EBTs) to meet patients where they are.

BILL TARKANIAN, B.A., J.D., L.A.A.D.C. is a recovering lawyer, and the Director of Program Development for L.A. CADA. He is an advocate for marginalized populations, including the homeless, the LGBTQ, and others who are systems impacted. He leads L.A. CADA's Court Diversion efforts as part of the agency's commitment to legal and health equity. Bill teaches as an Adjunct at Azusa Pacific University's Graduate School of Psychology (MFT track) and with Los Angeles Community Colleges.



DOUGLAS HAUBERT, Esq. is a skilled and experienced attorney. He was elected Long Beach City Prosecutor in 2010, and re-elected in 2014. He is known for his innovative and collaborative approaches to community safety, and nationally recognized for his diversion programs, including a recent pilot program involving the Department of Mental Health and L.A. CADA, known as Priority Access Diversion (PAD), aimed at helping high frequency, non-violent, misdemeanor defendants.



JENNIFER LOPEZ, M.A. Ms. Lopez has more than 25 years of experience in child welfare and protective services for the Los Angeles County Department of Children and Family Services (DCFS). She has held many management positions throughout the Department and is currently a Regional Administrator at the Santa Fe Springs office.



CHIEF JEFF PIPER has been the permanent police chief of the Whittier Police Department since 2011 and is a 26-year law enforcement veteran. Chief Piper has been recognized for his contributions in community policing, directed enforcement efforts, and the development and implementation of mission-based policing. He holds a B.A. in Criminal Justice from Cal State Fullerton and a MA from Cal State San Bernardino.



CINTHYA ALCARAZ, LCSW, Los Angeles County Department of Mental Health and Court Liaison, providing alternatives to incarceration. Cinthya provides staff coordination and services integration between the courts, the jails, and community-based treatment programs, with particular focus on balancing the needs of individuals and the expectations of the judicial system. She received her MSW from California State University Long Beach through the Advanced Standing Program.
