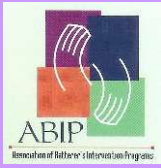

ABIP Faculty of Experts

Tom Bellows, PhD - Dr. Bellows is a seasoned and experienced BIP facilitator with perpetrators since 1994. He obtained his Ph.D. at the Union Institute and University in 1995 and gained his "Reality Therapy Certification" from "The William Glasser Institute" in 2004. Dr. Bellows has presented at many conferences and trainings and has published a multitude of articles.

Lynda Campbell - Currently volunteers at Angel Step Inn Emergency DV Shelter. Lynda was, formerly a staff member at Haven House, Inc. for 24 years, is an experienced counselor & group facilitator for male & female recovery programs, with emphasis on the impact of addiction on domestic violence.

Daniel Chinn is one of those people that has provided groups for a long time and is dedicated to the mission of addressing domestic violence in our society. He is a clinical social worker that has provided group working in his private practice, state hospital and state prison settings. He remains in private practice in San Luis Obispo County and is a certified provider for batterer intervention programming. He calls his program "Men Helping Men".

Michael Cochran BA, MBA (Banking & Finance). Twenty-nine years as a DV Facilitator/co-facilitator, facilitating Men's DV Group at Foothill Family Services also at Management 411. He also has expertise in intervention techniques for partner abuse, targeting self-esteem issues, rage, and anger, he also works with the interpersonal family issues. He also specializes in various ethnic cultural issues. Michael is also a long time ABIP Board Member and current Co-Chair.

Isabella Goeders, MS is an MFT intern at the Chinatown Service Center in Los Angeles where she is a therapist working with families, parenting classes, and as a DV facilitator. She was one of the founding members of the Asian Pacific Islander DV Task Force in 2004. Isabella was one of the recipients of the 2013 Woman of the Year for years of volunteer and advocate work done with DV victims.

Maria Levya has over 30 years of experience working at the Jewish Family Services and the LAPD assisting the domestic violence response team. She also founded The Children Safety Alliance Group (TCSA) which provides professional supervised visits to assist families going through divorce or separation to reunite with their children. Maria also founded Community Safety Alliance Group which is a family support and training agency. Her goal is to work with the justice system to assist our community with education to maintain families and avoid family separation.

Stephen Lasicka is a SUDCC III, has worked in AOD treatment for fourteen years. He facilitates and instructs batterers intervention, anger management and drug diversion at Tarzana Treatment Centers and alcohol/drug education counseling at Driver Safety School. He was previously involved in facilitator training at Homeboy Industries. His education includes a BA from UCLA, JD Loyola Law School and Addiction Studies certification at LA Pierce College.

Alyce LaViolette, MS, MFT - Founder of Alternatives to Violence in 1979 and has worked with battered women since 1978. Alyce is both a national and international speaker and trainer, as an expert witness and best-selling author for Sage Publications, with the 3rd Edition of her book, "It Could Happen to Anyone; Why Women Stay" (Available on Amazon.)

Cecelia Walker has worked in the field for 17 years, a survivor in Recovery since 2002. Her lived experience informs her passion for equitable, appropriate services to those in need. In 2004, a volunteer at Haven House, and was later hired as a Housing Case Manager and Outreach Advocate for Angel Step Inn DV Emergency Shelter. Cecelia holds a BA in Sociology and MS in Human Services, Certified Substance Abuse Counselor and is Co-Chair of the Religion & Domestic Violence Committee of the Los Angeles DV Council, member of the DV Alliance, LA Regional Policy Committee, and Community Action Network
